

SUMMARY ANNUAL REPORT

This is a summary of the annual report of the Cental Garden & Pet Co. Medical/Dental Plan, EIN 68-0275553, Plan No. 520, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Central Garden & Pet has committed itself to pay certain self-insured Medical, Dental, and Vision claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Kaiser Foundation Health Plan Inc Of Georgia, Curalinc Llc dba Curalinc Healthcare, Reliance Standard Life Insurance Company and Kaiser Foundation Health Plan Inc to pay Medical, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, and Wellness claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$4,971,951.
